You will also learn about the laws, rules, and procedures relevant to aerodromes, airspace and air services including emergency situations. You will also explore the concept of jurisdiction in an aviation regulatory environment domestically and internationally through practical case studies. The unit will also provide you with the skill to research and acquire the aeronautical knowledge requirements of the Civil Aviation Safety Authority Commercial Pilot Licence Air Law syllabus. Students who have completed the corresponding external CASA exam and want to be exempt from Assessment 1 (Quizzes) should contact the Unit Coordinator.
