This unit will provide you with an opportunity to apply the theoretical knowledge and practical skills you have attained in your course to the professional work environment. You will complete 15 days relevant industry experience with an emphasis on the interaction of your university learning with the practical environment. You are required to find your own placement or project and details of the placement or project must be provided to the unit coordinator prior to commencing the placement or project.
