General Information

Overview

Atoms, Molecules and Matter will provide you with an understanding of the basic principles of chemistry and how they apply to daily life. This unit will present fundamental chemical principles that are central to all sciences, including healthcare, biology, environmental science and agriculture. This unit will provide the foundation for further study in chemistry, biochemistry and molecular sciences. You will learn about matter and atomic structure, chemical bonding and the forces and chemical interactions between molecules. You will be introduced to the chemistry of electrolytes, acids, bases and buffers and enabled to perform calculations relating concentrations to the pH of strong and weak acids, bases and buffers. Understanding the naming and classification of chemical compounds will allow you to communicate effectively and precisely with your colleagues in science and industry. Basic nuclear radiation safety will be presented. This unit has a compulsory residential school. The residential school will emphasise laboratory safety and introduce you to skills relating to the preparation of standard solutions and volumetric procedures, titrimetric and spectrophotometric analyses and scientific report writing.

Previous Student Feedback

Feedback, Recommendations and Responses

Every unit is reviewed for enhancement each year. At the most recent review, the following staff and student feedback items were identified and recommendations were made.

Feedback from SUTE

Feedback

Students expressed mixed views about the residential school. Many found it valuable and engaging, while others felt the duration was too long or that activities did not cater well to students with differing levels of prior chemistry knowledge.

Recommendation

Review the structure and pacing of the residential school and explore opportunities to better accommodate students with varying levels of prior chemistry knowledge while maintaining learning outcomes.

Feedback from SUTE

Feedback

Some students indicated that the tutorial delivery could be more engaging, with additional explanation of worked examples and more support for students who are new to chemistry.

Recommendation

Review tutorial delivery with teaching staff to encourage more detailed explanations of worked examples and strategies to support students with limited chemistry background.

Feedback from SUTE

Feedback

A small number of students suggested that greater flexibility in the mode and timing of teaching would improve their learning experience, including preferences for in-person classes.

Recommendation

Continue to monitor student feedback regarding teaching delivery and consider feasible opportunities to enhance student engagement within the existing delivery model.

Feedback

A small number of students commented on the consistency of teaching staff and the availability of the unit coordinator during the term and residential school.

Recommendation

Review communication and staffing arrangements to ensure students have clear points of contact and a consistent learning experience throughout the unit.
