You will actively contribute to clinical decision making and be able to undertake clinical tasks under supervision. In order to pass this unit you must demonstrate a mastery level of knowledge and understanding of chiropractic procedures, processes and documentation and demonstrate compliance with Chiropractic Professional Competency Standards.
