Feedback

In light of the high risk of GenAI use in online and un-invigilated quizzes, assessment tasks should be reviewed to ensure rigorous assessment of student learning and knowledge.

Recommendation

It is recommended a Unit Update Proposal is submitted to move away from online assessments due to a high risk of GenAI use in un-invigilated and online quizzes. The weighting of online assessments will also be reduced to allow the rigorous assessment of student learning and knowledge through reflective assessments.

Recommendation
