In this unit, you will learn to configure sensors, actuators, and control equipment to solve industrial problems. You will assess multiple options and choose the best combination of components for your design. Additionally, you will create, evaluate, and simulate an automation solution to a given industry issue using industry-standard components, software, and PLCs.
