In this unit, you will have the opportunity to explore, evaluate and apply nursing theories and models that are currently used in the care of older people in different care settings – acute, community, and residential aged care. You will investigate societal perceptions of older people, ageing and the impact these perceptions may have on the older person. You will plan changes to enhance the organisational culture of your clinical setting to provide an environment that is conducive to meeting the clinical, social and psychological needs of the older person and their families.

#### Assessment Type

#### Task Description

##### Aim

The aim of this written assessment is to demonstrate your knowledge of the impact that societal values have on the older adult, and construct and justify strategies to develop a culturally competent workforce to meet the psychosocial care needs of older adults.

##### Instructions

You are writing an academic essay that requires you to select two societal views on the ageing older adult and critically analyse the effect of those views on the older adult. You should discuss how societal ageing affects economic growth, patterns of work and retirement, and the way family's function. Your discussion will include how the government and communities provide adequate resources for older adults, and the prevalence of chronic conditions and disability. Your discussion is to be substantiated by evidence-based literature.

Please follow the steps below to complete your assessment task:

1. Provide a brief introduction outlining the aim of your assessment (approximately 100 words).
2. Discuss two societal views on the ageing older adult in 2024 (approximately 300 words).
3. Discuss how societal ageing can affect economic growth, patterns of work and retirement, and the way family's function. This discussion should include innovative and contemporary processes to support older adults and their families (approximately 400 words).
4. Critically analyse how the government and communities will (approximately 500 words):
  - Provide adequate resources for older adults.
  - Prevent chronic conditions and disability.
  - Support safe, quality, clinical, social, and psychosocial care for older people.
5. Justify how your findings can assist in developing positive health outcomes for older people by incorporating contemporary evidence and national standards (approximately 500 words).
6. Provide a concise conclusion summarising the main concepts in your assessment (approximately 200 words).

### Assessment Type

### Task Description

#### Aim

The aim of this assessment is for you to analyse and critically discuss factors affecting a sustainable workforce in caring for older people to meet the needs of older adults and their families across diverse care settings.

#### Instructions

To complete this assessment, read the case below and follow the steps below.

#### Case Study

You were successful in obtaining a new position as a registered nurse in a residential aged care facility. You have been working in the facility for six months and notice a high turnover of registered nursing staff. During your time working in the facility, you note the low morale among staff and the negative working environment. The negative working environment is affecting the retention of skilled workers, which is impacting the provision of safe, competent nursing care to older people who have the right to safe quality nursing care that is person-centred and culturally inclusive. You discuss your concerns with the facility manager and express that staff have a lack of cultural understanding and that more education is needed about culturally and linguistically diverse residents and approaches to increase cultural competence within the workforce at the facility.

After discussing the situation with the facility manager, they acknowledged they need to improve the delivering of services that are culturally safe, respectful, and inclusive. The facility manager asked you to be involved in a working group to create a culturally responsive approach to meet the needs of all culturally diverse residents in the facility. You agree to participate in the working group and start to prepare for your first meeting.

1. Provide a brief introduction outlining the aim of your assessment (approximately 100 words).

3. Critically analyse the factors affecting the recruitment and retention of registered nurses including personal, institutional, and societal factors (approximately 900 words).
4. Analyse research evidence in relation to current policy directions and standards, to enhance a competent, culturally aware, inclusive, person-centred framework to meet the needs of older adults and their families. Your discussion should include implications for health policy and be substantiated by the literature with reference to

the Aged Care Quality Standards (approximately 1000 words).

5. Provide a concise conclusion summarising the main concepts in your assessment (approximately 200 words).
