Topics include business models and strategy; risk management; professional standards and ethics; electronic practice management systems; automation and technological innovation including social innovation; sustainability, growth and marketing; financial management; self-management; and leadership. This unit is essential for students wanting to understand and research the business of law and prepare for the business aspects of legal practice, including the regulatory requirements of legal practice.
