You will apply your knowledge of highly complex physiological and psychosocial factors that impact upon the childbearing continuum. In addition to this, you will employ midwifery knowledge, cultural safety, and inclusivity in the care of marginalised groups such as women experiencing substance misuse, and/or incarceration, refugee and immigrant women, or members of the Lesbian, Gay, Bisexual, Transgender, or Queer (LGBTQ+) community. The clinical practicum component of this unit will require you to complete a minimum of 224 hours in addition to Continuity of Care Experiences (COCE).
