## General Information

### Overview

In this unit, you will have the opportunity to consolidate your nursing practice in a clinical environment. You will apply the relevant Nursing and Midwifery Board of Australia (NMBA) Professional Standards and the National Safety and Quality Health Service Standards (NSQHS) in your practice as a nursing student. You will be expected to identify risk and recognise and respond appropriately to the needs of the patient in the simulated and clinical environments. You will review the concept of scope of practice using the Decision-Making Framework (DMF) (NMBA, 2020). You are required to participate in a compulsory three (3) day, 24-hour residential school or equivalent prior to attending professional experience placement for this unit. This unit includes a 240 hour block professional experience placement in a clinical environment. You must meet specific mandatory health, safety and security requirements to be eligible to attend each professional experience placement. Professional experience placements may be limited in your community, and you may be placed in other locations. Please be prepared financially and personally to cover the costs of relocating for placements. Due to the limited availability of placements, some block placements have start and/or end dates that fall outside standard term dates. The accreditation requirements for this course state that NURS13145 must be commenced and completed within the final six months of your enrolment in the Bachelor of Nursing course. Please be aware that if you receive a fail grade in any other unit during your final term, you will be required to repeat both the failed unit and NURS13145. This is necessary to ensure you meet the accreditation standards for course completion.

Students who do not drop the unit in this timeframe cannot later drop the unit without academic and financial liability. ##### Feedback

##### Feedback

##### Recommendation

Continue providing deliberate practice sessions to address individual learning needs effectively. These sessions allow students to focus on specific skills and competencies, fostering confidence and competence through targeted, self-paced practice.

#### Feedback from Unit Coordinators.

##### Feedback

It is recommended to continue supporting students on clinical placement through regular phone calls, timely emails, and 360° meetings involving students, clinical assessors, and unit coordinators to address any performance concerns as they arise.

##### Recommendation

This ongoing support enhances students' placement experience by providing real-time feedback, addressing learning needs promptly, and ensuring consistent communication among all parties involved. These measures help students remain on track with their learning objectives, fostering a supportive and responsive learning environment on placement.

#### Feedback from In-class Feedback.

##### Feedback

Students highly valued the career planning session in residential school, which included practical interview practice, insights into graduate year expectations, and guidance from CQU Careers.

##### Recommendation

Maintain the career planning session as a key component of residential school. This session prepares students for transition to the workforce by enhancing their interview skills, providing essential information about the graduate year, and connecting them with valuable career resources.
