Feedback

Clinical educators are reporting an increase in the number of students requiring pastoral support throughout clinical placements. Reports of increased anxiety during clinical placements being a large area of concern.

Recommendation

It is recommended that the unit coordinator explores the reason behind the increase in student mental health concerns throughout clinical placements in more detail. Discussions will be held with clinical educators and the physiotherapy academic team to identify some strategies on how to better support both students and clinical educators.
