Overview

In this unit, you will develop practical skills and deepen your knowledge relevant to the professional practice of psychology as an evidence-based scientific discipline. You will explore how social, historical, professional, and cultural factors shape psychology, and apply this understanding across diverse contexts. You will learn the appropriate administration, scoring, and interpretation of psychological tests under supervision, supported by psychometric theory applied to varied assessment scenarios. Ethical and legal frameworks are emphasised, with a focus on cultural responsiveness, professional communication, and interviewing skills, alongside awareness of how psychological practices may be misused. By completing this unit, you will demonstrate competencies in interpersonal communication, psychological assessment, and intervention strategies consistent with APAC pre-professional practice requirements.
