Overview

This unit will introduce you to key research interests in the positive psychology domain, and the various methodological approaches to research as they relate to positive psychology. You will be encouraged to consider how research evidence contributes to best practice. You will learn skills in interpreting and critically evaluating the quality of published research evidence, and consider the ways research knowledge can be used to guide intervention design and procedures. There will be an overarching focus on becoming a critical consumer and user of this scientific research literature to inform the development of future research questions, intervention strategies, and professional practice.
