You will learn about product lifecycles, from design through end of use, and the related environmental impacts, including the conduct of waste audits. Specific lifecycle studies might focus on council or local government recycling initiatives, or composting at a household, community, or industrial scale. You will explore how social innovation initiatives such as makers spaces, men's and women's sheds and other similar enterprises keep materials in use longer while also benefitting social capital.
