General Information

Overview

In this unit you will explore the complexity and fluidity of cultural constructs. You will examine the notion of culture as an 'identity' framework for people and will consider the ways in which populations are categorised, located, stratified and frequently stigmatised on the basis of their conformity to or deviation from dominant cultural norms. This exploration will include both long recognised indices of cultural variation: race, ethnicity, religion and class, and more recently acknowledged cultural discourses: gender, age, disability, gender-identity and sexual orientation. You will examine the development of discriminatory structures and practices, and consider their impact on and implications for social work services in Australia. You will investigate the knowledge and skills required for culturally safe and sensitive practice, and will explore your own cultural background, and reflect on how your values and assumptions might impact your practice.
