You will develop knowledge in how to support language and literacy needs for children who are culturally or linguistically diverse, have hearing loss or a disability. The International Classification of Functioning, Disability and Health framework, and the principles of evidence-based, and interprofessional practice will be applied throughout the unit. In this unit you will engage in a work integrated learning experience to develop professional speech pathology skills.
